## RESOLUTION DESIGNATING NEW REVIEW OFFICERS TO REVIEW AND CERTIFY MAPS AND PLATS FOR FORSYTH COUNTY, NORTH CAROLINA IN ACCORDANCE WITH N.C. GENERAL STATUTE 47-30.2 (CITY-COUNTY PLANNING AND DEVELOPMENT SERVICES DEPARTMENT)

WHEREAS, N.C. General Statute 47-30.2 requires that the Forsyth County Board of Commissioners designate by name one or more persons experienced in mapping or land records management as Review Officers to review and certify maps and plats as required before being presented for recording in the office of the Register of Deeds; and
