SUMMARY OF INFORMATION:

Bids were received July 6, 2017, for the purchase of ten 2017 all-wheel drive Police Pursuit Vehicles (PPV's). Summary of bids received follows:

WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 Noon, on Thursday, July 6, 2017, for the purchase of ten 2017 all-wheel drive Police Pursuit Vehicles (PPV's) at the request of the Forsyth County General Services Department and intended for use by the Forsyth County Sheriff's Office and the following bids were received:

WHEREAS, the bid offered by Horace G. Ilderton, LLC for Dodge Chargers is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers competitively obtained purchasing services at discount prices to public agencies, in compliance with N.C.G.S. 143-129(e)(3); and

WHEREAS, it is the recommendation of the County Manager, the County General Services Director, and the City/County Purchasing Director that a contract for the purchase of ten 2017 all-wheel drive Dodge Charger PPV's in the amount of \$23,753 each be awarded to Horace G. Ilderton, LLC for a total amount of \$237,530; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of these contracts.

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners, that a contract for the purchase of ten 2017 all-wheel drive Dodge Charger PPV's in the amount of \$23,753 each is hereby awarded to Horace G. Ilderton, LLC in the total amount of \$237,530 and that all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Horace G. Ilderton, LLC for the purchase of ten 2017 all-wheel drive Dodge Charger PPV's consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
