SUMMARY OF INFORMATION:

On August 8, 2016, the Forsyth County Board of Commissioners held a Public Hearing on the Order authorizing \$350,000,000 School Bonds, \$65,000,000 Community College Bonds, and \$15,000,000 Parks and Recreational Facilities Bonds. After the Public Hearing, these orders were placed on the November 8, 2016 ballot for voter approval. All three orders were approved by a majority of the voters.

On December 19, 2016, the Forsyth County Board of Commissioners adopted the 2016 Forsyth Technical Community College Capital Projects Ordinance which appropriated the first \$16,250,000 of issued bond proceeds. This agenda item is necessary to move funds from a Budget Reserve in order to allow Forsyth Technical Community College to proceed with the first two projects, including \$10,000,000 for the Aviation Center, and \$6,250,000 for the Oak Grove Center and Main Campus Renovation.
