2. The Sheriff's Office entered into a two year agreement with the Town of Walkertown to provide 1 full time Sheriff's Deputy as part of a new Mini-COPS program. Forsyth County will pay the Salary & Benefit costs for the position and be reimbursed 50% of the personnel costs by the Town of Walkertown. After the 2 year agreement is complete, the Town may continue to receive the additional service but will bear 100% of the costs. The County Manager made the Board aware that Contingency would be used to cover the operating costs for FY2015. Revenue for the Town's share, it will be posted to the appropriate account as it comes in quarterly.
