## RESOLUTION AWARDING A CONTRACT FOR COOLING TOWER REPLACEMENT AT THE FORSYTH COUNTY LAW ENFORCEMENT DETENTION CENTER (GENERAL SERVICES DEPARTMENT)

WHEREAS, after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 2:00 PM, on Friday, July 8, 2015, for the purchase and installation of cooling towers at the Law Enforcement Detention Center with the following bids received:

WHEREAS, R. P. Murray, Inc., provided Affidavit C committing to 17% M/WBE subcontractor participation; and

WHEREAS, it is the recommendation of the County Manager, General Services Director, and the Purchasing Director that a contract for the purchase and installation of cooling towers at the Law Enforcement Detention Center at the base bid amount of \$567,700 be awarded to R. P. Murray, Inc.

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

**NOW, THEREFORE, BE IT RESOLVED** by the Forsyth County Board of Commissioners, that a contract for the purchase and installation of cooling towers at the Law Enforcement Detention Center at the base bid amount of \$567,700 is hereby awarded to R. P. Murray, Inc.

**BE IT FURTHER RESOLVED** that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with R. P. Murray, Inc., for the purchase and installation of cooling towers at the Law Enforcement Detention Center in the amount of \$567,700, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

**BE IT FURTHER RESOLVED** that R. P. Murray, Inc., will be required to subcontract with minority owned businesses in the amount of 17% as indicated on its Affidavit C.

BE IT FURTHER RESOLVED that all other bids are hereby rejected.
