EXPLANATION:

This Budget Ordinance Amendment appropriates additional Special Children's Adoption Funds in the amount of \$14,400 allocated to the Forsyth County Department of Social Services to match the State funding level.

The Special Children's Adoption funding is a restricted fund balance and annual appropriation that consists of money from the North Carolina Department of Health and Human Services, to be used solely to promote adoptions in Forsyth County. Forsyth County Department of Social Services received an additional \$14,400 from the North Carolina Department of Health and Human Services in late March.
