BOARD MEETING MINUTES  
August 18, 2015**

**Meeting Called to Order**

An organizational meeting of the Forsyth County Board of Elections was called to order in the second floor meeting room on August 18, 2015. The meeting called to order at 3:30 P.M., Chairman Ken Raymond presiding.

**Pledge of Allegiance**

Chairman Raymond led the pledge of allegiance.

**Moment of Silence**

Chairman Raymond led a moment of silence.

**Public Comment Session**

Chairman Raymond opened the public comment session with instructions. Speakers were asked to complete a public comment card and would have three minutes or less to speak. The speaker's name and address should be stated for the record. Questions should be included during the allotted time and answers would be given at the close of the session. A speaker's time could not be given to another individual. At the close of the public comment session, no additional statements or questions would be heard from the public. The public comment session included the following speakers:

Chairman Raymond moved to close public comments; Member El-Amin motioned, Secretary Russell seconded; **Motion carried unanimously.**

Chairman Raymond deferred to Mr. Joyner regarding Ms. Henley's request for lists of the Chief and Precinct Judges. Mr. Joyner offered to provide lists after the Board had passed

resolution for the appointments noting that they would speak after meeting to schedule time to pick up the lists.

### **Chief Judge/Judge Appointments**

Interim Director Joyner gave the floor to Jacob Wright to provide further information on the lists provided to the Board for the Chief Judge and Precinct Judge Appointments. Mr. Wright thanked Marilyn Baker of the Democratic Party as well as Ann Grammer of the Republican Party for their work and providing the names in a timely manner. Mr. Wright noted that there would be additional names added as they are filled for 2016 additionally noting that the 19 precincts for the Municipal elections were fully covered.

Chairman Raymond thanked the Chief Judges and Precinct Judges for volunteering their time during the election season, enabling the elections to run smoothly.

Member El-Amin inquired of time frame allowed to fill the 14 Republican slots currently unfilled for precincts; additionally inquired of back up list for potential judges. Mr. Wright confirmed that there was a list available if needed, also addressing the period for submitting names by the parties. Interim Director Joyner called on the Board to remind the parties that appointments are a 2-year commitment.

Secretary Russell joined Chairman Raymond in thanking Chief Judges and Precinct Judges for their efforts.

Member El-Amin called for a point of consideration regarding increase of salaries for the officials; Mr. Joyner stated that the office would consider an increase in salary for the pollworkers.

Chairman Raymond moved to approve the lists of chief and precinct judges as provided, Member El-Amin motioned, Secretary Russell seconded; **Motion carried unanimously.**

### **Additional staffing for precincts**

Chairman Raymond deferred to Interim Director Joyner; Mr. Joyner addressed the many changes covered at the conference, noting that additional workers are going to be needed in 2016 due changes in the law regarding reasonable resemblance and reasonable impediment; complicated judgments will be required of the judges and staff at precincts. To enable a smooth process believes that an increase of staff will be required, estimating that there will be a need for at least three additional assistants at each precinct. Chairman Raymond inquired about a greeter, and provided a brief overview of the greeter's duties as suggested by the State Board. Mr. Joyner did clarify that there would be a greeter; noting however they may not be exclusively greeters but would be utilized in additional areas of need. Interim Director Joyner also addressed the need for additional workers during early voting. Secretary Russell inquired if Mr. Joyner could foresee any challenges getting additional workers, if funding or recruiting would be a challenge. Interim Joyner noted that due to the need for increased staffing and the budget constraints, pay increases would have to be balanced with the need for increased staffing. Mr. Joyner deferred to Mr. Wright to address staffing through Temporary Resources and their capacity to fill the personnel needs. Wright noted at this time Temporary Resources had been called on to provide temporary staff during early voting only; however, information will be posted on the Board Elections

website as well as Forsyth County's website to recruit workers. Mr. Wright noted that interest in working would increase as the election drew closer.

### **Precinct 068 - Good Shepherd Moravian - 1474 Kerner Rd, Kernersville**

Interim Director Joyner provided information to the Board regarding the use of Precinct 068; Ms. Beverly Johnson with Good Shepherd Moravian stated that they were no longer going to use the facility and were in the process of relocating; noting that they were going to rent or sell the property. Per Mr. Joyner, the property is in Kernersville and is unincorporated noting that it will not affect the elections of 2015 but will require elections office to find an alternate location for 2016. Due to area, being unincorporated, public facilities may be limited and that staff will begin looking for an alternate, staff would update the Board accordingly.

### **Electronic Poll book Update**

Mr. Joyner revisited the information provided by the former director; free software is available from the state though it is not without operations cost; also noting that poll workers will not be familiar with the new software. OVRID was used during a prior election cycle; however office moved back to use of EVID; OVRID would be able to be used in 2015 with minimal cost, however 2016 would see an increase in cost involved. Mr. Joyner did inquire of the Board if they would want to be a part of the process as the office was looking to have something in place by September prior to municipals. Mr. Duffey stated that the State is starting to push the technology for the front-end check in and the back end for voter history; it is not mandatory or statutory yet. Many counties are moving to the electronic poll book for check in. Mr. Wright noted that EVID is certified. The Board inquired when a selection would be needed; Mr. Joyner stated he would like to have a decision no later than the next meeting, staff will provide Board with recommendations and analysis of both systems.

### **Approval of Minutes**

Chairman Raymond called for review and approval of minutes for July 21, 2015 and August 13, 2015; Secretary Russell notes typographical changes needed for July 21, 2015. Chairman Raymond moved for approval of July 21, 2015 minutes with changes and August 13, 2015's minutes as provided; Member El-Amin motioned, Secretary Russell seconded; **Motion carried unanimously.**

### **Board Comments**

Chairman Raymond opened for comments. Chairman Raymond took opportunity to comment on former Director Hines, noting that he did a great job and worked hard for Forsyth County, wishing he had stayed, noting Greene County is fortunate and wished him well in his new position. Secretary Russell concurred with Chairman Raymond, additionally stating that it was sad to see him go, though respects his decision. Secretary Russell as well as other Board members offered their appreciation to Mr. Joyner for stepping into the Interim position. Member El-Amin thanked Mr. Hines for his service; believed his intent was honorable and labored to make himself available to the public. Member El-Amin also noting that Mr. Joyner has on two occasions stepped in as Interim; and believes that he and the staff should be applauded for always being able to fulfill their responsibilities to the citizens of Forsyth County, insuring that their votes counted.

### **Other Business**

Interim Joyner asked to include other business to discuss early voting sites for 2016 noting need to move forward on additional sites. Secretary Russell asked if Mr. Joyner could provide a deadline to assist in

the selection process. Interim Joyner stated that a tentative list prior to the November election would be welcomed. Mr. Joyner also addressed upcoming absentee meetings; October 13, 2015, October 20, 2015, and October 27, 2015; all statutory and all at 5 P.M.; would like to have a tentative One-Stop list no later than October 27, 2015. Though it may not be final list, would like to be able to give notice to locations regarding tentative use. Secretary Russell inquired if there would be a meeting to finalize which locations would be used. Mr. Joyner said he would like to have sites notified prior to holidays. Interim Joyner confirmed with the Board the already scheduled meeting September 17, 2015 at 4 pm; provided Board with date of Canvass, November 10, 2015 at 11:00 a.m.; and Municipal Election November 3, 2015. Mr. Joyner provided additional clarification to Board's resolution for using Hanes Hosiery in lieu of Hanes-Lowrance Middle School; citing N.C.G.S §163-130.1 which provides,

“A county board of elections, by unanimous vote of all its members, may establish a voting place for a precinct that is located outside that precinct. The county board's proposal is subject to approval by the Executive Director of the State Board of Elections. The county board shall submit its proposal in writing to the Executive Director. Approval by the Executive Director of the county's proposed plan shall be conditioned upon the county board of elections' demonstrating that: (1) No facilities adequate to serve as a voting place are located in the precinct; (2) Adequate notification and publicity are provided to notify voters in the precinct of the new polling location; (3) The plan does not unfairly favor or disfavor voters with regard to race or party affiliation; (4) The new voting place meets all requirements for voting places including accessibility for elderly and disabled voters; and (5) The proposal provides adequately for security against fraud. Any approval granted by the Executive Director for a voting place outside the precinct is effective only for one primary and election and must be reevaluated by the county board of elections and the Executive Director annually to determine whether it is still the only available alternative for that precinct.” (1999-426, s. 3(a); 2001-319, ss. 3(a), 11.)

Chairman Raymond inquired if contacting Kim Strach for approval would provide the solution necessary to make the change. Mr. Joyner noted it would.

### **Closed Session (if needed)**

Chairman Raymond motioned to go to closed session citing N.C.G.S §143-318.11(a)(6), which enables the Board, “To consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee; or to hear or investigate a complaint, charge, or grievance by or against an individual public officer or employee.” Member El-Amin seconded motion. Session closed at 4:25 p.m.

### **Adjournment**

Board reconvened open session at 5:25 p.m. announcing that the Board unanimously decided to terminate a staff member, Jacob Wright. No further comment provided. Chairman Raymond called for any additional business; no additional business was put before the Board. Chairman Raymond moved to adjourn, Member El-Amin motioned, Secretary Russell seconded. Meeting adjourned at 5:26 p.m.
